Proses Manage - COBIT process will be used to assist in collecting data and observations of the department concerned which will be audited. Audited results by the end of this report will also contain opinions and input on to the company concerned, in order to assist the company in order to continue increase the effectiveness and efficiency, in this case not with reduce the number of workers but could further improve the work system with the help of information that is better, and achieve the final goal of the vision and mission of PT Daya Adira Mustika.
