Background of the Study

They do not notice doublespeak and even worse, people always get misled by it. Actually, we can easily spot doublespeak in many fields of life. However, for this thesis I would like to analyze doublespeak in a political speech.

Tuesday, November 8, 2016 was the day of the United States presidential election. The world put their eyes on this memorable event. For months, the two main parties, the Democratic and Republican parties had been working the presidential campaign subject of the two candidates of the next America's president. The candidates are Hillary Clinton from the Democratic Party, and Donald Trump from the Republican Party.
