Background of the Study

One of the most famous dark romanticist figure is Edgar Allan Poe. Poe is considered to be the founding father of the pyschological thriller and mystery. "In the area of popular literature, he is said to have fathered the modern detective story and some forms of science fiction" (Dameron). One of Poe's strong charateristics is in showing emotion in his writing,

In Poe's writings there is despair, hopelessness; and the echoes of a melancholy extremely touching to those who read with a remembrance of his broken life, but nowhere in them does "conscience roused, sit boldly on her throne." The ideas of right and wrong are as feeble in his chains of thought as in the literature of Ancient Greece. (Daniel)

His works cannot be easily interpreted. There is no right or wrong interpretation, meaning, the interpretation can vary greatly depending on one's experience and knowledge.

While Poe has considerable amount of works, three particular poems are really caught my interest, they are namely "To One Departed", "To One in Paradise", and "Annabel Lee." These three poems bring up lost and death and how it affect a person life which is the most recurring idea in a Dark Romantics literary work. In addition to that, these three poems are beautifully crafted in showing the painful tragedy of lost and death with contrast of love and life.

The main objective of this study is to try to convey the theme of the literary work through the diction used. According to the *Oxford Dictionary of Literary Terms*, Theme is "A salient abstract idea that emerges from a literary work's treatment of its subject-matter; or a topic recurring in a number of literary works"("Theme"). While diction is "the choice of words used in a literary work"("Diction").

Formalism will be used as an approach of this study with consideration that in trying to convey the theme of the poems through its diction, relying solely on its source material is deemed sufficient.
