# **CHAPTER ONE**

# INTRODUCTION

### **Background of the Study**

In this major thesis, I intend to discuss George Bernard Shaw's <a href="Pygmalion">Pygmalion</a> and Willy Russell's <a href="Educating Rita">Educating Rita</a>. These two plays share the same issues which are male characters' unfair treatment towards the female protagonists and their struggle against it. These two plays also want to show the development of the two female protagonists through education.

<u>Pygmalion</u> is originally written in 1912. The female protagonist, Eliza Doolittle, comes from a poor family and speaks with a terrible accent, and because of that reason, she gets the unfair treatment from Professor Higgins, a scientist of phonetics. <u>Educating Rita</u> is written in 1985. The female protagonist, Rita, feels that her life is mapped out by her family and friends. This is even worse by the fact that her husband urges her to have a baby and forbids her in having a higher education. These two plays are written in

different period; however, both plays show that inequality to women still exists.

In this major thesis, I propose to analyze portrayal of the female protagonists in the two plays. According to A.S Hornby in Oxford Advanced Learner's Dictionary, portrayal is defined as "the act of showing or describing somebody or something in a picture, play, book, etc" (Hornby, 2005: 1172). Through portrayal of the female protagonists, I will analyze their position in the different periods of twentieth century and the changes of the female protagonists after being enlightened by education.

Having read the two plays, I would like to analyze the following problems as follows:

- 2. How do the two female protagonists develop?

# **Purpose of the Study**
