## **CHAPTER ONE**

#### **BACKGROUND OF THE STUDY**

In this thesis, I want to analyze theme through inner conflicts which has been experienced by the characters in the story. According to Perrine's <u>Story and</u> <u>Structure</u>, "conflict is a clash of actions, ideas, desires, or wills" (Perrine 42). "The central conflict and its outcome" (Perrine 110) create an excitement for readers. In my opinion, the inner conflicts in this novel are important issues to analyze because it can reveal the main idea of the story. According to Perrine's <u>Story and Structure</u>, inner conflict is "conflict with some element in his own nature (man against himself)" (Perrine 42). From the inner conflicts which are experienced by the characters, I can see how the characters must struggle between
